The meeting was called to order by District Attorney Brian Hall, at 7:03 p.m. with 64 registered voters present. The meeting was digitally recorded by TK Menesale, District Treasurer, Clerk.

To elect by floor vote a temporary moderator

A **MOTION** from the floor was made to nominate Peter Meier which was duly seconded. As there were no further nominations, a **MOTION** was made to close nominations. There was **unanimous approval** to elect Peter Meier to be moderator for the special election.

The moderator called for floor nomination of the three candidates for a 1-year term (not a two-year term). A **MOTION** was made to accept the three candidate's nomination papers, all three candidates were nominated from the floor, and there

was unanimous approval of the three candidates on the election ballots. A **MOTION** was made to close nominations. There was **unanimous approval, and the motion passed.**

To elect by ballot (1) member of the Board of Water Commissioners to fill the vacancy for (1) year expiring at the annual meeting April 2022.

Ballots were distributed to all registered voters at the meeting check-in. The three candidates were Eda Cardoza, Neil Langille and Mark McMahon. Completed ballots were placed in the secure ballot box. The meeting paused while the ballots were counted by Louise Warren, billing clerk, District's Attorney Brian Wall, and TK Menesale, District Treasurer, Clerk. Results of the election were then presented to the Moderator. Neil Langille received a total of 12 votes. Eda Cardoza had a total of 25 votes. Mark McMahon had a total of 27 votes. A **MOTION** was made to elect Mark McMahon to the position of Buzzards Bay Water District Commissioner for a one-year term. The candidate was sworn in by Brian Wall, Esq.

With no further business to come before the voters, a **MOTION** to Adjourn was made from the Floor 7:16 p.m. and was duly seconded. **There was unanimous approval.**
