Then and there to act upon the following articles:

- ARTICLE 1.** To elect by ballot a Moderator for a term of one (1) year.
- ARTICLE 2.** To elect by ballot one (1) members of the Board of Water Commissioners for a three (3) year term.
- ARTICLE 3.** To elect by ballot one (1) members of the Board of Water Commissioners for a three (3) year term.
- ARTICLE 4.** To see if the District will vote to raise and appropriate or transfer from available funds in the treasury an amount of money to defray the **operating expenses of the District** for the fiscal year beginning July 1, 2023 (FY24) including Maintenance and Operations, Service Connections, Legal & Engineering Expense, Insurance Expense, Administration and Clerical, Debt & Interest, Elected Officials Salaries, Salaries and Wages, Miscellaneous Expense and such other expenses as may be deemed necessary by the Board of Water Commissioners, or act anything thereon.
- ARTICLE 5.** To see if the District will vote to raise and appropriate or transfer from available funds in the treasury a sum of money to be added to the **Stabilization Fund**, or act anything thereon.
- ARTICLE 6.** To see if the District will vote to raise and appropriate or transfer from available funds in the treasury, a sum of money to be added to the **Special Purpose Future Storage Tank(s) Stabilization Fund Account**, or act anything thereon.

- ARTICLE 7.** To see if the District will vote to raise and appropriate or transfer from available funds in the treasury a sum of money to be added to the **Special Purpose Future Capital Outlay Expense Stabilization Fund**, or act anything thereon
- ARTICLE 8.** To see if the District will vote to adopt G.L. c. 203C and authorize the Custodian/Trustee of the OPEB Fund established under G.L. C. 32B § 20 to invest monies in the OPEB Fund under the prudent investor rule established in G.L. c. 203C, or to take any other action relative thereto.
- ARTICLE 9.** To see if the District will vote to raise and appropriate or transfer from available funds in the treasury a sum of money to purchase and equip a new Backhoe, or act anything thereon.
- ARTICLE 10.** To see if the District will vote to transfer a sum of money from the **Special Purpose Future Storage Tank(s) Stabilization Fund Account** for the purpose of funding the repainting of the hydropillar inside and out.
